| <b>Purpose of the report</b>   | <ul style="list-style-type: none"> <li>To update the HWBB with changes to pharmaceutical Service access (community pharmacy locations) since publication of the Dudley PNA 2015.</li> </ul>   |
| <b>Key points to note</b>      | <ul style="list-style-type: none"> <li>The Health and Social Care Act 2012 transferred the responsibility to develop and update PNAs to Health and wellbeing Boards (HWBBs) from April 2013.</li> <li>The current regulations (The National Health Service (Pharmaceutical and Local Pharmaceutical Services) Regulations 2013) make provisions for the conduct of PNAs. Dudley HWBB published its first PNA by April 1<sup>st</sup> 2015 (available at <a href="http://www.allaboutdudley.info/AODB/navigation/bn_briefing.asp?page=4">http://www.allaboutdudley.info/AODB/navigation/bn_briefing.asp?page=4</a>).</li> <li>Regulation 4(2) requires each HWBB in so far as is practicable, to keep up to date the map which it includes in its PNA pursuant to paragraph 7 of Schedule 1 (without needing to republish the whole of the assessment or publish a supplementary statement). This map identifies the premises at which pharmaceutical services are provided in the area of the HWBB.</li> <li>With respect to pharmacy access, one pharmacy has closed, one distance selling pharmacy has opened, two pharmacies have changed ownership and one pharmacy has had a minor relocation.</li> <li>Overall, access to pharmaceutical service provision for the Dudley population remains unaffected by these changes.</li> <li>Supplementary statement approved by the Dudley Community Pharmacy Development Steering group.</li> </ul> |
