**Purpose of Report**

- To seek the active involvement of a range of partners and agencies in delivering the Community Renewal Action Plan
- To invite other partners and agencies to attend future meetings on specific topics where appropriate.
- To further develop a deliverable Community Renewal Action Plan and report on progress to the Brierley Hill Area Committee Community Renewal and Young People's Working Group and also the Brierley Hill Area Committee

### **Finance**

4. Any costs arising from the appointment of working groups will be met from existing resources.

### **Law**

5. Since Working Groups do not have the status of formal Committees, the rules of proportionality which relate to seats on Committees under Section 18 of the Local Government and Housing Act, 1989 and the Local Government (Committees and Political Groups) Regulations, 1990 are not applicable.


### **Equality Impact**
